

CLARIFICATION OF FAMILY TIES: RESIDENCE PERMIT APPLICATION FOR SPOUSE

This form is for you if your spouse is applying for his/her first residence permit in Finland on the basis of family ties. You have a Finnish residence permit and your spouse intends to move to Finland and to lead a family life with you. Your spouse is your husband/wife, your registered partner of the same gender or a cohabitee with whom you have lived in a marriage-like relationship for at least two years, or with whom you have joint care of a child.

Submit this form to the permit authority as an appendix to the application form proper (OLE_PH1) filled in by your spouse. Please enter the information required on yourself, your spouse and your family ties.

Carefully fill in and sign the application. Incomplete information will delay the processing of the application and may lead to its rejection.
