

The Embassy of Georgia in New Delhi informs visa applicants that for issuance of visa a prior approval from authorities in Georgia is required.

The process takes from 7 to 30 working days.

The Embassy advises visa applicants to submit applications at earliest possible.

Types of visas available:

- Diplomatic
- Service
- Ordinary/Study
- Transit

Diplomatic Visa:

Diplomatic visas are issued to:

- The head of state;
- Speaker of the Parliament;
- Other state authorities;
- Members of the official delegations;
- Family members of officials accompanying them during the trip;
- Other persons accompanying the state officials during their stay in Georgia;
- Diplomatic couriers.

Service Visa:

Service visa is issued to the holders of a service passport on the basis of the official request of a foreign state.

Ordinary and Study Visa:

Ordinary and Study visas are issued to persons intending to travel to Georgia for Study or other purposes.

In order to obtain Georgian Ordinary Visa, citizens of the Republic of India should submit the following documents:

- Genuine invitation letter from Georgia (In case of a student – admission letter from the University);
- Duly filled application form with 3X4 size photograph of the applicant;
- Copy of the Passport;
- Receipt, certifying payment for consideration visa issuance;
- Travel Insurance valid in Georgia;
- Proof of sufficient funds for stay in Georgia;
- Two way ticket booking;
- Hotel booking or exact address of place where visitor will reside during a trip.

Transit visas

Transit Visas are issued to foreign citizens for the transit purpose to enter a third country. The requirements for the transit visas are as follows:

- Visa for the Country of destination;
- If visa is not required, any other document certifying that a person will be allowed to cross the border;
- Itinerary;
- Transit visa will not exceed 72 hours.

Fee for consideration of issuance of Ordinary and Study visa:

- 90 days single entry – 954 INR; (20 USD)
- 90 days multiple entry – 1 431 INR; (30 USD)
- 360 days multiple entry – 2 385 INR; (50 USD)

Fee for consideration of issuance of Transit Visa:

- Single entry Transit visa – 239 INR (5 USD)
- Multiple entry Transit visa – 1 431 INR (30 USD)

Fee for consideration of issuance of Georgian visa in non-refundable

The Embassy of Georgia reserves the right to refuse issuance of the visa without explanation to the applicant

Incomplete applications will be returned to the applicant at their cost

- Applications may be submitted by post (all post expenses should be covered by the applicant).
- In case of positive decision, applicant must come in person to the Embassy to obtain visa.

Visa fee should be paid in favour of the Embassy of Georgia, Consular Fee
